- **May 17-10 AM-12 PM**, neighborhood open house.

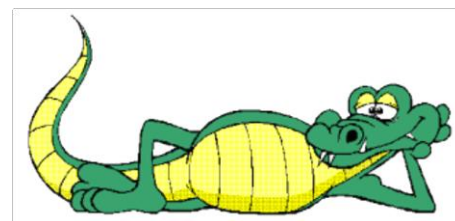

Guest Policies:

Forest Hollow Swim Club welcomes the guests of members. To ensure fairness and ease of implementation, every guest, including houseguests and out-of-town guests, is required to have a guest pass upon entering the pool. These can be purchased at the front desk for \$5, or in books of ten for \$40. (Pay by check or exact change, please.) Guest passes do not have an expiration date. **Forest Hollow Members must accompany their guests while at the pool.** Guests must be registered on the sign-in sheet at the front desk with an emergency phone number provided.

Membership Policy Overview :

Members must be current on their dues to use FHSC, and due to insurance requirements, guests MUST be accompanied by a member—no exceptions. Guests must also have a guest pass to enter the pool.

Forest Hollow Swim Club is a non-profit corporation funded solely by its shareholders and the sale of summer memberships. To become a shareholder of FHSC, you must obtain a pool share. Shares are available through the Board for \$250 or from current members who wish to sell their share. Previous summer members may obtain a share from the board for a reduced rate of \$200. There is a maximum of 300 shares available—summer memberships fill any vacancies. If FHSC reaches the maximum number of shareholders, no summer memberships will be available.

Johathan Lash, pool member, coordinates FHSC shares. The buyer and seller negotiate the price, which does not include annual dues.

Please include your email address when you register. This enables us to communicate with members about pool closures, an upcoming event, or other important information. FHSC will send an email to membership when the pool is closed for weather, special events, or other reasons that may require the pool to close unexpectedly. This information also will be distributed via Twitter and Facebook.

Shareholders who want to keep their share but do not wish to use the facility this season are required to pay an inactive fee.

Please tell your friends about our great pool community. A solid membership helps us to keep down the cost of annual dues and enables us to maintain our facility to a high standard.

Cost of Parties

To reserve the pavilion for a party, a \$25 fee and \$5 per non-member guest is required. Parties of more than 25 people may require additional lifeguard fees and pool board approval. The cost will be based upon party size. Please contact Anne Halal for more information about hosting a party for more than 25 attendees.
